Karla Carmichael Grant Application

Proposed Protocol:

1. Call for proposals will be distributed to the professional membership of AAPT via email.
2. Interested applicants will be able to download the application from the AAPT website.
3. Applicants will submit applications to the AAPT secretary by **May 9, 2008**.
4. The secretary will remove the application cover sheet, which will contain identifying information about the applicant(s) and will assign the application a random identification number and will distribute the application (minus the cover sheet and the vita) along with an application evaluation form to the grant committee.
5. The grant committee will consider the applications and will evaluate them. After scoring the applications using the application evaluation form, the committee will compare their findings and recommend to the Executive Board the dispensation of the grant applications by June 5, 2008.
6. In the event of a tie, the entire Executive Board will be called upon to decide the dispensation of the grant application.
7. Grants recipients will be notified on June 6, 2008 of the dispensation of their grant application.
8. Grants will be awarded at the Spring Workshop on June 6, 2008.
